## **PROGRAM OVERVIEW**

GLEAMNS Head Start is a federally funded program designed to provide comprehensive child care services to low-income children and their families. Children who attend Head Start participate in a variety of educational activities. They receive medical and dental care, have healthy meals and snacks, and enjoy playing indoors and outdoors in a safe setting. GLEAMNS Human Resources Commission, Inc. has operated a highly successful Head Start Program since 1966.



The Head Start Act requires periodic federal reviews of all Head Start programs. The Program received a Focus Area Two review, which was conducted January 31, 2022,

through February 4, 2022. This review was conducted through a hybrid method (both virtual and in-person). Based on the information gathered during the review, the Program was found to meet the requirements of all applicable Head Start Program Performance Standards, laws, regulations, and policy requirements. On February 9, 2023, a monitoring review was conducted from a self-reported incident. During that review, the Program was issued two areas of noncompliance and given 120 days for correction. Corrective action plans were developed and implemented to address the two areas of noncompliance. These plans have been submitted to the Office of Head Start for review and approval.

According to the last Community Needs Assessment, GLEAMNS continues to see a high number of children and families needing Head Start or Early Head Start services. The data from the Community Needs Assessment reflect 64,251 children, ages 0-4, live in poverty in South Carolina. Of the population living in poverty, 13,325 are in the GLEAMNS service area. Of the approximately 13,325 children in poverty, 7,995 are Early Head Start eligible infants and toddlers, and 5,330 are Head Start eligible preschool children.

## HEAD START PHILOSOPHY

The GLEAMNS Head Start/Early Head Start Program is based upon the philosophy that all children, including the child with disabilities, need a comprehensive, interdisciplinary program to help them develop and to work toward solving their problems. We believe the child's entire family, as well as the community, should be involved.



## **BUDGET INFORMATION**

GLEAMNS has developed and maintained a reputation for fiscal excellence. An annual agency-wide audit and periodic monitoring visits are conducted by various funding sources. Fiscal audits and reviews consistently disclose no disallowances or questioned costs. The last audit was completed November 2, 2023, by Manley Garvin, LLC, for fiscal year April 1, 2022, through March 31, 2023. This audit did not disclose any deficiencies or material weaknesses in internal control over compliance applicable to major programs. Funds for Head Start are allocated in eight main categories.

## **ENROLLMENT- HEAD START**

Services are provided to the entire family with a concentration on the child between the ages of 3-5 years old. During the 2022-2023 school year, the Head Start Program was funded to serve 1424 preschool children and their families in Greenwood, Laurens, Edgefield, Abbeville, McCormick, Newberry, Saluda, Lexington, and Richland, counties. The Program served 57% of its funded Head Start enrollment slots.



## **MENTAL HEALTH**

GLEAMNS Head Start/Early Head Start Program supports a program-wide culture that promotes positive mental health and social and emotional well-being. Mental health services were provided by licensed mental health professionals. Our mental health consultants help to ensure the timely and effective identification of and intervention in family and staff concerns about children's mental health. Mental Health professionals provided training or support on social and emotional development, behavior management, strategies for assisting children to develop self-regulation skills, and stress management. Mental Health professionals also provided ongoing observations of individual children and the environment to assist in determining the need for intensive intervention or a formal evaluation by the local school district. Mental health consultants supported families through telehealth services and provided families with activities and strategies for children's social-emotional development. Mental health services were made available to 818 children and their families.

### DISABILITIES

Children with disabilities are included in the full range of services provided for all Head Start children and receive services related to special education. To ensure screenings and services are provided in a timely manner, we collaborate with 14 school districts throughout our ten-county service area. During the school year, 55 preschool children were diagnosed with having special needs. This number if significantly low due to the local education agencies delaying services because of ongoing COVID-19 challenges. See chart below for the number of children diagnosed with a specific disability.



## **TRANSITION SERVICES**

Children in new situations need guidance about what to expect in the next setting. The more the new setting reflects children's background and previous experiences, the more successful children and families will be in making transitions and meeting new challenges.

All Head Start centers promote effective transition from our Program to the child's next educational placement. The Program has collaborative agreements with the

Local Education Agency in our ten-county service area. The agreements outline steps to be followed to support children transitioning from Head Start to kindergarten. Approximately 211 children transitioned from Head Start to public school settings or other learning facilities.

## **EDUCATION SERVICES**

During the year, teachers and teacher assistants used Creative Curriculum, a research-based early childhood curriculum, to engage children in educational activities. This curriculum promotes school readiness in the areas of: Language Development, Cognitive Development, Literacy Development, Mathematics Development, Social-Emotional Development, Physical Development, and Approaches to Learning. Creative Curriculum is based on scientifically valid research and has standardized training procedures and materials to support implementation. Additionally, Creative Curriculum is aligned with the Head Start Early Learning Outcomes Framework and South Carolina Early Learning Standards. The goals of the early learning standards are:

- To support the readiness of young children through a nurturing early care and education environment and developmentally appropriate practices through the development of voluntary guidelines as required by the Good Start, Grow Smart Initiative.
- To educate and provide guidance for families, educators, caregivers, administrators, and policy makers on developmental expectations for children during the preschool years.
- To inform the development of program standards across early learning environments.
- To strengthen partnership between current early childhood efforts funded by federal, State, local, and private funding to create nurturing early childhood environments.

The Creative Curriculum is linked to comprehensive, ongoing assessment with developmental and learning goals. Our Program uses Teaching Strategies GOLD as the ongoing assessment. The assessment is organized into three observation periods for Head Start and four observation periods for Early Head Start. The results are analyzed and aggregated after each observation period. Teaching teams also review and analyze their assessment data to form their planning and instructional strategies relating to individual children or groups. The data also guide our decisions for continuous classroom and program improvement, professional training, and financial decisions.






## **EDUCATION SERVICES**

At the end of each observation period, the teaching team completes a narrative report to share with parents during home visits or parent-teacher conferences. An individual child report is developed for each child, and this report allows teachers and administrators to see how each child is performing during the assessment checkpoint period or progressing over multiple checkpoint periods. The "Widely Held Expectations Report" compares information for each child, class, or group, placing children into three categories: below, meeting or exceeding widely held expectations. This report allows teachers and administrators to know where children are relative to most children of the same age or class.

Below are the outcomes results for children during the last reporting period of the 2022-2023 school year.



Improvement Plan: Teachers will continue to develop lesson plans that include activities and experiences to support learning and development in all developmental areas and include opportunities to maximize instructional time during routines, such as mealtime, transitions, etc. In addition, teachers will receive additional training and support in developmental areas, where needed.

## **School Readiness Goals**

Head Start defines school readiness as children possessing the skills, knowledge, and attitudes necessary for success in school and for later learning and life. One of the goals of GLEAMNS Head Start includes preparing children for kindergarten and engaging parents in the process of nurturing and educating their children. The outcomes of our children are evaluated based on the following school readiness goals:

## CLASS (CLASSROOM ASSESSMENT SCORING SYSTEM)

In April 2022, independent consultants conducted classroom observations using the CLASS assessment tool. The CLASS is a system for observing and assessing the quality of interactions between teachers and students in the classroom. It also measures instructional and social interactions proven to contribute to student's academic achievement and social competencies. The Program's last CLASS review by the Office of Head Start (OHS) was conducted February 1-5, 2016. The chart below shows the OHS scores from the on-site review in 2016, the 2021-2022 Program scores, and the 2020 national median CLASS scores. Teachers and teacher assistants will receive on-going training that will lead to improved CLASS scores and enhanced skills for supporting children's learning.



The Office of Head Start suspended CLASS reviews in 2020 due to the COVID-19 pandemic. CLASS reviews are scheduled to resume during fiscal year 2024.

Significant CLASS Changes: Grantees with a CLASS score below one or more of the competitive thresholds will be designated for competition. Specifically, the competitive threshold for Classroom Organization is raised from 3 to 5, and Emotional Support is raised from 4 to 5. In addition, the competitive threshold for Instructional Support is raised from 2 to an interim threshold of 2.3 through July 31, 2025. For reviews conducted on or after August 1, 2025, the competitive threshold for this domain raises to 2.5.

## **HEALTH SERVICES**

GLEAMNS' commitment to wellness embraces a comprehensive vision of health for children, families, and staff. Our goal is to ensure, through collaboration among families, staff, and health professionals, all child health and developmental concerns are identified, and children and families are linked to an ongoing source of continuous, accessible care to meet their basic health needs. Caseworkers continued to follow up on the health care needs of children in their contact with parents during morning drop off, afternoon pick up, or weekly phone calls.

\*To enhance the development of very young children.


\*To promote healthy family functioning.

## **DISABILITIES SERVICES**

The Early Head Start Program has a collaborative agreement with BabyNet, which is South Carolina's interagency early intervention system for infants and toddlers under three years of age with developmental delays or who have conditions associated with developmental delays. Twelve children were determined eligible by BabyNet to receive early intervention services under the Individuals with Disabilities Education Act. Nine children were determined eligible to receive early intervention services prior to enrollment.



## **MENTAL HEALTH SERVICES**

Mental health services are provided to children, parents, and staff through contracts with Beckman Mental Health Center, Lexington Mental Health Center, and private consultants. Our mental health consultants provide training to promote mental wellness, such as stress management, team building, and social-emotional development. No children received direct services from a mental health professional; however, approximately 60 enrolled families had access to mental health services.

## EARLY HEAD START-CHILD CARE PARTNERSHIP


